The Oregon State Highway Division (State) and the City of Portland (City) entered into an agreement, dated March 29, 1976, covering construction and maintenance of the West Portland Park and Ride Station.

It has now been determined by State and City that the aforementioned agreement, although remaining in full force and effect, should be supplemented by this agreement to provide for the redesign of the traffic signal installation in order to eliminate a serious operational and maintenance problem caused by pedestalmounted signals in the median of Barbur Boulevard.

The proposed work will be funded on the basis of 50 percent State and 50 percent City. State Construction Funds are to be utilized to finance the State share of costs.

The City will furnish all necessary design work, labor, material and equipment to accomplish the installation, compile accurate cost accounting records and, upon completion of the project, forward to State an itemized statement of the actual total costs incurred by City. State shall promptly reimburse City for 50 percent of said costs.

The parties hereto mutually agree and understand that the agreement of March 29, 1976 shall remain in full force and effect, and apply with like force and effect to this supplemental agreement wherever applicable.

IN WITNESS WHEREOF, the parties hereto have set their hands and affixed their seals as of the day and year hereinafter written.

ORDINANCE NO. 150201

An Ordinance authorizing the City to enter into an agreement with the Oregon State Highway Division providing for design, construction and finance of signal modifications on Barbur Boulevard at the entrance to the West Portland Park and Ride Station and declaring an emergency.

The City of Portland ordains:

Section 1. The Council finds:

- Ordinance 141338 passed by the Council February 25, 1976 authorized the City to enter into agreement 15266 with the Oregon Department of Transportation (ODOT) providing for design, construction and finance, utilizing Interstate Highway Funds, of the West Portland Park and Ride Station.
- 2. Traffic signals mounted on pillars on islands on Barbur Blvd. at Taylors Ferry Road and in front of the Park and Ride Station have been repeatedly knocked down, and put out of operation by vehicle damage.
- 3. ODOT has prepared an agreement for City approval providing for the City to install mast arm supported signals and agreeing to pay half the costs for the work.

NOW, THEREFORE, the Council directs:

a. The Commissioner of Public Works and the Auditor are authorized to execute on behalf of the City, an agreement similar in form to the agreement attached to the original of this Ordinance and by this reference made a part hereof.
