An Ordinance transferring appropriations within the General Fund in the amount of \$345, for the purpose of appropriating contract funds to the Bureau of Economic Development for the continuation of the State of Oregon Department of Environmental Quality contract with the City of Portland; and declaring an emergency.

The City of Portland ordains:

Section 1. The Council finds:

- Pursuant to Ordinance No. 146812, the City of Portland authorized the acceptance of a contract in the amount of \$15,000 with the State of Oregon Department of Environmental Quality in which the City of Portland agreed to carry out certain professional services related to air quality planning.
- Of the contract amount of \$15,000, expenditures during FY 1978-79 and FY 1979-80 totalled \$14,655, leaving a balance of \$345, as shown below:
