## ORDINANCE NO.

## 150222

An Ordinance authorizing the transfer of \$12,000 within the General Fund from the Bureau of Police to Transfers to Other Funds - Fleet Management and increasing the appropriations of the Fleet Management Fund, Bureau of Fleet Management, by \$12,000 for the purchase of used motor vehicles and declaring an emergency.

The City of Portland ordains:

Section 1. The Council finds:

- 1. That the Bureau of Police recently reorganized its Juvenile Division to provide for a Community Juvenile Officer (C.J.O.) program.
- 2. That the C.J.O. program requires that each of the twelve (12) Officers assigned thereto, be equipped with a used motor vehicle as they will be working directly in the schools making presentations.
- 3. That the funds needed for the purchase of the said vehicles may be obtained by transfer of monies appropriated in the FY 80-81 budget for the Bureau of Police, Juvenile Division, for Local Travel.
- 4. That the appropriations should be transferred to the Bureau of Fleet Management for the coordination and purchase of said vehicles.
