SUBJECT: Correction to the Tax Levy in the Approved Budget

With this memo, the City Budget Office is providing an updated report for the City Council to consider as the Budget Committee on May 26, 2021. This update is to correct the tax levy as approved by vote on May 13, 2021. As the vote for levying taxes was taken by the Budget Committee the correction must also occur with a brief reconvening to read and vote on the correct tax levy for the new Parks Operating Levy in order to move the budget through to its final phases. The following attachment has been revised with the language added in red to illustrate the change. There is no planned testimony as this is filed as a report for a technical correction on the tax levies and the City has already taken public testimony on the Approved Budget.

1. <u>Convene Budget Committee.</u> Mayor convenes Council as the Budget Committee for purpose of approving a budget.

2. <u>Vote to Approve Tax Levies.</u> The Budget Committee approved tax levies on May 13, 2021, and must also add the recently approved Parks Local Option Levy. Mayor reads the following script:

THE CITY SHALL LEVY ITS FULL PERMANENT RATE OF \$4.5770 PER \$1,000 OF ASSESSED VALUE; AND \$27,763,868 FOR THE PAYMENT OF VOTER-APPROVED GENERAL OBLIGATION BOND PRINCIPAL AND INTEREST; AND \$209,860,034 FOR THE OBLIGATIONS FOR THE FIRE AND POLICE DISABILITY AND RETIREMENT FUND; AND \$0.80 PER \$1,000 OF ASSESSED VALUE FOR THE PARKS LOCAL OPTION LEVY; AND \$0.4026 PER \$1,000 OF ASSESSED VALUE FOR THE CHILDREN'S LEVY. FURTHERMORE, THE CITY SHALL LEVY THE AMOUNTS LISTED IN ATTACHMENT E FOR URBAN RENEWAL COLLECTIONS.

- 3. The Mayor calls to entertain a motion and vote to approve the tax levies.
- 4. <u>Adjournment</u>. The Mayor adjourns the Budget Committee session.
