ORDINANCE No. 150851

An Ordinance waiving Section 33.98.040 of the Code to permit late acceptance of Variance No. VZ 318-80, and declaring an emergency.

The City of Portland ordains:

Section 1. The Council finds:

- The Variance Committee, on September 9, 1980, acting on the application of A. H. Edwards and Richard B. Edwards, deedholders, granted Variance No. VZ 318-80 to reduce the minimum front yard (east along SW 19th) from the required 15 feet to 2 feet; in order to enlarge a commercial structure (presently used for equipment rental, on Tax Lots 91, 109, and 124, Section 21, 15, 1E located at 8205 S.W. Barbur Blvd. No appeal was filed of such approval.

 Pursuant to Section 33.98.040 of the Code, written acceptance was required prior to October 26, 1980. Late acceptance was received November 14, 1980.
- 2. The auditor requests waiver of the 30 day limit for filing acceptance in order to avoid substantial hardship and unnecessary costs.

NOW, THEREFORE, The Council directs:

- a. That Section 33.98.040 of the Code be waived in order to render late acceptance of Variance No. VZ 318-80 to be valid and the variance to be in full force and effect.
- Section 2. The Council declares that an emergency exists because the variance described in Section 1 above should be effective immediately in order to avoid unnecessary delay and additional costs; therefore, this ordinance shall be in full force and effect from and after its passage by the Council.
