An Ordinance amending Title 33, Planning and Zoning, of the Code of the City of Portland, Oregon, subsection 33.120.040(b) to make clear that the Historical Landmarks Commission must adopt rules and regulations to carry out the intent of this chapter, and declaring an emergency.

The City of Portland ordains:

Section 1. The Council finds:

- 1. That Title 33, Planning and Zoning, of the Code of the City of Portland, Oregon, at subsection 33.120.040(b) provides that the Portland Historical Landmarks Commission "may" adopt rules and regulations to carry out this chapter.

- a. That Title 33, Planning and Zoning, of the Code of the City of Portland, Oregon, is amended by amendment to subsection 33.120.040(b) to read as follows:
 - "33.120.040 Functions and duties. (a) XXX no change.
 (b) The Portland Historical Landmarks Commission
 shall adopt such rules and regulations as it finds
 necessary or appropriate to carry out the intent
 of this chapter.
 - (c) to (m) XXX no change.

Section 2. The Council declares that an emergency exists because it wishes to make clear that it is complying with State law by requiring that the Landmarks Commission adopt rules and regulations to regulate its actions; therefore, this ordinance shall be in full force and effect from and after the day of its passage by Council.
