ORDINANCE NO. _ 150880

An Ordinance creating seven positions and abolishing six positions in the Budget Office, establishing a salary rate for the Compensation Plan, transferring appropriation in the amount of \$12,450 within the General Fund from General Operating Contingency to the Budget Office, and declaring an emergency.

The City of Portland ordains:

Section 1. The Council finds:

- The positions established in the FY 80-81 budget for the Budget Office had not been reviewed and classified by the Bureau of Personnel Services.
- 2. The classifications which have been established by the Bureau of Personnel Services differ from those included in the budget and six positions of Fiscal Amalyst should be abolished and five positions of Management Analyst (0827) and one position of Services Research Director (0815) should be created.
- The salary rate for the Services Research Director should be established in the Compensation Plan.
- 4. One additional position of Assistant Management Analyst (0826) should be created to handle increased workload and responsibilities assigned to the Budget Office.
- 5. The necessary additional appropriation to fund this position should be provided by transfer from General Operating Contingency.

NOW, THEREFORE, the Council directs:

a. The following positions are hereby created in the Budget Office (306) with salary rates in accordance with the current Compensation Plan or as established in c. below:
