## ORDINANCE NO. 150935

An Ordinance authorizing acceptance of a CETA Title III contribution in the amount of \$16,000 to the Administrative Cost Pool, Grant No. 41-1-010-ADMIN, from the U. S. Department of Labor to fund the administrative component of a Youthful Offender Employment Program, under the City of Portland, Human Resources Bureau, AU 682, Training and Employment Division for the period from December 10, 1980 through September 30, 1981, amending the FY 1980-81 City Budget by increasing appropriations and declaring an emergency.

The City of Portland ordains:

Section 1. The Council finds:

- Pursuant to Ordinance No. 150846, passed by Council on December 10, 1980, the City of Portland accepted Grant No. 41-1-010-YOEP in the amount of \$64,000 from the Department of Labor to provide training and employment services to City youth with criminal records.
- 2. The funds accepted at that time represented only the services portion of the project budget.
- 3. The Training and Employment Division has now received notification of an award of \$16,000 to the CETA Administrative Cost Pool to cover the administrative costs of the project.
- 4. It is therefore appropriate that the Mayor accept, on behalf of the City, a CETA Title III contribution to the Administrative Cost Pool, Grant No. 41-1-010-ADMIN in the amount of \$16,000 from the U. S. Department of Labor as shown in Exhibit "A".

NOW, THEREFORE, the Council directs:

a. The Mayor is hereby authorized to accept, on behalf of the City, a CETA Title III contribution to the Administrative Cost Pool, Grant No. 41-1-010-ADMIN in the amount of \$16,000 from the U.S. Department of Labor to provide the administrative component of the Youthful Offender Employment Program under the Human Resources Bureau, AU 682, for the period from December 10, 1980 through September 30, 1981 as set forth in Exhibit "A", amending the FY 1980-81 City Budget by increasing appropriations.
