### Purpose of proposed legislation and background information:

This ordinance is being proposed to accept a grant to advance the Age-friendly City program within the Bureau of Planning and Sustainability to:

- Engage community members to develop a framework for an Age-Friendly Civilian Corps ("AFCC").
- Select and train neighborhood "business ambassadors" to help reactivate neighborhood business districts and main streets.
- Hire an artist to create a mural through an agreement with the Bureau of Planning and Sustainability.
- These actions support the following Community Involvement Goals from the 2035 Comprehensive Plan: partnerships and coordination, community capacity building, agency capacity building, representation, and early involvement.

# Financial and budgetary impacts:

Accepting the 2021 AARP Community Challenge Grant has the following financial and budgetary impacts:

- This legislation will not create new City staff position.
- There is no match requirement, but BPS is proposed to provide match of \$1,000 for mural project from the Bureau of Planning and Sustainability Comprehensive & Strategic Planning Program General Fund.
- The total grant budget is \$20,000, which will be incorporated into the BPS FY2021-22 budget under grant number PN000100. The grant budget includes \$6,500 in personnel costs for the age-friendly program manager and \$13,500 for other expenses.

### Community impacts and community involvement:

- This grant proposal was developed in coordination with the Age-friendly Portland and Multhomah County Executive Committee, the Age-Friendly Employment and Economic Development Committee, and through engagement with local community members.
- As part of the project Black, Indigenous and people from communities of color will be recruited to be a part of each aspect of the project in the following ways:
  - Develop a framework for an Age-Friendly Civilian Corps with age-, race, and ability-diverse Portlanders to better understand the barriers and opportunities related to community engagement.

- Business Ambassador project: Age- and race-diverse community members will be recruited to support local business districts and main streets by serving as "greeters", in collaboration with AARP Oregon, Venture Portland, and local business associations.
- Age-friendly mural: A Black/Latinx woman will lead the mural project, including co-creating the mural with an age-, race-, and ability-diverse group of community members.
- The project will focus geographically in neighborhoods on Portland's eastside with intentional outreach to the historic Albina community and other racially-diverse areas of the city.
- Local businesses districts and main streets on the eastside will be the focus on the business ambassador program, with a specific focus on multicultural businesses.
- Livability will be addressed as a part of the project by focusing on post-pandemic economic recovery for multicultural business; also, livability will be enhanced by creating visual art (a mural) and co-creating a framework for future civic engagement.
- There are no significant objections to this project; AARP Oregon and the Age-Friendly Portland and Multnomah County Executive Committee have supported the development of the proposal and its elements.
