ORDINANCE No. 91023

An Ordinance accepting certain property for the opening and extension of N.E. Holman Street, and declaring an emergency.

The City of Portland does ordain as follows:

Section 1. That the following described parcel of property be and is hereby accepted for street purposes:

Deginning at a point in the north line of the Isaac homnison b.L.C. which point is 50 feet west of the Intersection of the north line of the Isaac Rennison D.L.C. and the east line of Section 13. T. 1 N., R. 1 E., W.M.; thence west following the morth line of the Rennison D.L.C. 273.41 feet to a pipe; thence southerly and parallel to the east line of sold Section 13, 110.9 feet to a pipe in the north line of .E. Holman Street, as now laid out; thence casterly along the north line of sold N.E. Holman Street to a point which is 15 feet distant from the cald wost line, when measured at right angles thereto; thence northerly parallel to the east line of sold Section 13 to a point which is 60 feet southerly of the north line of sold Rennison D.L.C., when measured at right angles thereto; thence oasterly parallel to and 60 feet distant from the north line of sold Rennison D.L.C. to a point in the northerly line of N.E. Holman Street; thence along the northerly line of M.E. Holman Street; thence along the northerly line of M.E. Holman Street to the west line of M.E. 42nd Avenue; thence northerly along the west line of M.E. 42nd Avenue to the point of beginning.

Section 2. That the City Aud tor be and he is hereby directed to have the dead for street purposes as described in Section 1 of this ordinance placed on record and a copy of said ordinance forwarded to the County Assessor.

Section 3. Inasmuch as this ordinance is necessary for the immediate preservation of the public health, peace and safety of the City of Portland in this: To avoid any unnecessary delay in the widening and extension of this proposed street; therefore, an emergency is hereby declared to exist and this ordinance shall be in force and effect from and after its passage by the Council
