I would rather see my tax dollars go to housing and rehabilitation programs than to a program that I effectively keeps people from leaving trash in public parks.

I reside in and own a downtown condominium within the Clean & Safe district. As a condominium, we are required to pay into Clean & Safe (C&S) each year while a virtually identical rental property across the street does not. This arbitrary drawing of ESD boundaries is a bit absurd.

The downtown condo owners not only pay more in property taxes than our neighboring for profit apartments, but we are also tagged with supporting C&S.

"Business improvement districts (BIDs) sit at the intersection of these twinned forces of privatization and criminalization of the unhoused. A BID is an urban area within which private entities are empowered to conduct functions traditionally relegated to local government, including the maintenance of public space and security.

"To be unhoused in the United States is to be subject to punishment for your presence — for your mere existence. Homelessness is often painted as a regrettable consequence of personal failings, a "blight" harmful to tourism and business. But at its root, this

crisis is structurally produced, resulting from the dismantling of public housing and mental health treatment. It is a testament to Ronald Reagan's legacy of austerity, interwoven with the march toward privatization of public goods. A knee-jerk response of power structures has been to effectively treat being unhoused as a criminal status, exacerbating the crisis in the process.

The formation of ESDs is patently undemocratic. To institute one in Portland, interested parties form a business nonprofit and campaign to have the city's revenue division levy fees on in-district property owners in accordance with the city code. Then unelected ESD overseers — often some of the wealthiest enterprises in the city — use the proceeds to hire security and police, contract cleaning companies, make infrastructural improvements, and fund their lobbying and marketing efforts.

The audit revealed that the City of Portland has done little to carry out its required oversight procedures. In the case of Clean & Safe, the city did not fulfill any obligation except the collection of fees — declining to review the ESD's annual budget and scope of work, monitor the use of district funds, or conduct financial and performance audits, and, significantly, failing to assess and investigate complaints about security officers. The other two newer ESDs were also granted carte blanche.

Clean & Safe pays the full salaries of four dedicated police officers. These are public employees, invested with the power to carry out the full spectrum of policing actions while on the corporate payroll." MORE COMPLETELY UNTOUCHABLE COPS WITH NO ACCOUNTABILITY AT ALL TO PERFORM VIOLENCE ON THE MENTALLY ILL AND HOMELESS! Why???

City Council is despicable liars if they continue down this path... ESDs " are publicly funded and privately controlled to target and displace the most vulnerable communities in each city: the unhoused. They serve large corporate donors and major property owners, and very little else except money."

This is a waste of money and time and will help no one who actually needs help. Shame on you all if you pass this which we know you will because you all ROUTINELY IGNORE THE WILL AND WELLBEING of your constituents and then you throw up your hands and ask why so many have lost faith in government and have turned away from all your processes and hoops to jump
