ORDINANCE No. 151360

An Ordinance amending Ordinance No. 150580 in order to more accurately reflect in the Comprehensive Plan the role of City Council relative to the Metropolitan Service District's Solid Waste Management Plan, and declaring an emergency.

The City of Portland ordains:

Section 1. The Council finds that:

- 1. The present language of the Comprehensive Plan Policy 11.28 has been objected to by the Metropolitan Service District (Metro) as a possible hindrance to formal intergovernmental coordination relating to Metro's Solid Waste Management Plan.
- Alternative language proposed by Metro is acceptable and meets the objectives of the Comprehensive Plan and City Council intent for this Policy.
- 3. The City Planning Commission considered the proposed amendment on April 7, 1981, and recommends that the Council adopt the proposed language.
- 4. It is in the best interest of the City to expedite State acknowledgment of the Comprehensive Plan.

NOW, THEREFORE, the Council directs:

a. That Ordinance No. 150580 be amended by changing Comprehensive Plan Policy 11.28 to read as follows:

11.28 DISPOSAL

Participate in the preparation and implementation of the Metropolitan Service District's Solid Waste Management Plan as appropriate.

Section 2. The Council declares that an emergency exists because amending the language of Policy 11.28 will clarify the City's intent for this Policy, result in a recommendation of acknowledgment of the Comprehensive Plan from Metro to the Land Conservation and Development Commission, and reduce delay in receiving such acknowledgment. The Council further directs that this Ordinance shall be in full force and effect from and after its passage by the Council.
