ORDINANCE No. 151576

An Ordinance authorizing a Purchase Order with Bugge Investments, Inc., d.b.a. Columbia West Materials and Constructors Co. for the Bureau of Parks Portland International Raceway Pit Area Paving II in the amount of \$27,750, authorizing the drawing and delivery of warrants, and declaring an emergency.

The City of Portland ordains:

Section 1. The Council finds:

- 1. Bugge Investments, Inc., d.b.a. Columbia West Materials and Constructors Co. submitted the lowest responsible quote in the amount of \$27,750 for the Portland International Raceway Pit Area Paving II project.
- a. Appropriation is available within the Bureau of Parks, Portland International Raceway budget.

NOW, THEREFORE, the Council directs:

- a. The Purchasing Agent shall issue a Purchase Order with Bugge Investments, Inc., d.b.a. Columbia West Materials and Constructors Co. for the Portland International Raceway Pit Area Paving II project in the amount of \$27,750.
- b. The Mayor and the Auditor hereby are authorized to draw and deliver warrants chargeable to the 1980-81 budget, Bureau of Parks, Portland International Raceway, RU 137, Object Code 630, when demand is presented, approved by the proper authorities.
- Section 2. The Council declares that an emergency exists because a delay in proceeding with the purchase may result in an additional expense, and will unnecessarily deprive the City of the benefits of completion at an early date; therefore, this ordinance shall be in force and effect from and after its passage by the Council.
