ORDINANCE No. 151579

An Ordinance authorizing a transfer of appropriation within the Metropolitan Arts Commission between major object codes and declaring an emergency.

The City of Portland ordains:

Section 1. The Council finds:

- 1. The Metropolitan Arts Commission has a savings of \$2,500 within its Personal Services Budget; and, in order for the Arts Commission to provide assistance for the Folkarts Festival, requires this transfer of appropriation.
- That the City of Portland and Multnomah County have established the Metropolitan Arts Commission in order to promote and encourage public programs to further the development and public awareness of, and interest in, the performing and visual arts.
- 3. Sufficient appropriation is available within the FY 1980-81 budget in Personal Services, line item 100; and Benefits, line item 170.

NOW, THEREFORE, The Council directs:

a. \$2,500 is transferred as follows:
