

ORDINANCE No. 151581

151581

An Ordinance amending Ordinance No. 151256, being an ordinance assessing upon certain property the cost of abating and removing certain nuisances, including a fee for administration expenses for the one-month billing period ended December 31, 1980, by cancelling the assessment for Lots 4 - 6, Block 15, West Piedmont and reducing the total assessment by \$107.10, and declaring an emergency.

The City of Portland ordains:

Section 1. The Council finds:

1. Ordinance No. 151256 assessed Lots 4-6, Block 15, West Piedmont, \$107.10 for the cost of abating and removing certain nuisances, including a fee for administration expenses for the one-month billing period ended December 31, 1980, and entered in the City Lien Docket Book 125, Page 52.
2. This lien was paid as an invoice and should not be included in the assessment.

NOW, THEREFORE, the Council directs:


- a. Ordinance No. 151256 is amended by cancelling the lien against Lots 4-6, Block 15, West Piedmont, of \$107.10 and reducing the total assessment of \$3,696.46 to \$3,589.36.

Section 2. The Council declares an emergency exists because of the necessity of keeping the City's financial records accurate; therefore, this Ordinance shall be in force and effect from and after its passage by the Council.
