Dear Mr. Doane:

In response to your request by telephone to Ram Sharma, and in conformance with previous discussions, we have prepared a proposed scope of additional work for stress analysis studies for Bull Run Dam No. 1 and an estimated cost for performing this work. A copy of the IECO's proposal (Appendix A) is enclosed for your review.

The proposed scope of work is based on our understanding of the work considered necessary to develop appropriate and effective response to Army Corps of Engineers' comments on IECO's "Interim Report on Phase I Investigations, September 1979". The Corps comments are contained in their letter dated 5 June 1980 to the State Water Resources Department, a copy of which was forwarded to us.

The proposed lump sum engineering cost for performing the scope of work outlined is \$6,000.00.

IECO can perform this work as an addition to the already completed Phase I of the current agreement for Bull Run Dam No. 1 Stability Studies.

APPENDIX A

PRICE PROPOSAL FOR ADDITIONAL STRESS ANALYSIS WORK FOR BULL RUN DAM NO. 1

SECTION I - GENERAL

This proposal is prepared in response to the 16 October request by telephone from Mr. James L. Doane, Manager, Bureau of Hydroelectric Power, City of Portland, for a cost estimate for performing additional stress analysis work for Bull Run Dam No. 1. The additional work is considered necessary to develop appropriate and effective response to Army Corps of Engineers' comments on IECO's "Interim Report on Phase I Investigations - September 1979." The Corps' comments are contained in their letter dated June 5, 1980 to the State Water Resources Department, a copy of which was furnished to IECO with letter dated June 12, 1980 from Chief Engineer, Bureau of Water Works, City of Portland.

The proposal describes the scope of additional work for stress analysis to develop necessary response to Corps' comments and the estimated cost for performing the proposed scope of work.

The work described herein will be additional to the already completed Phase I of the Technical Services Agreement dated April 1979 between the City of Portland and IECO for the Bull Run Dam No. 1 Stability Studies.

SECTION II - SCOPE OF WORK

IECO will perform engineering services to accomplish the proposed scope of work for additional stress analysis studies described as follows:

2.1.1 STRESS ANALYSES STUDIES

• Two-dimensional finite element stress analysis of the maximum dam section for PMF loading (Res. W. S. El 1057.5; T.W. El 886.5)

including a crack extending from the upstream toe along dam base for a length established according to the criteria by U. S. Bureau of Reclamation (now Water Power Resources Service); uplift corresponding to the PMF loading condition applied as upward point loading along the dam base.

- Conventional gravity stress analysis of the maximum dam section having radial planes instead of parallel planes one foot apart for comparison of stability for the two cases.
- Preparation of summary report, and drawings showing graphic presentation of the results and evaluation of dam stability.

2.1.2 COMPLETION TIME

Completion time for the work included herein will be 2 calendar weeks (14 days) following notice to proceed with the work.

2.1.3 ESTIMATED COST

The cost for performing the work described herein is estimated to be \$6,000 detailed as under:

ORDINANCE NO. **151583**

An Ordinance amending Contract No. 17772 with International Engineering Company, Inc., and authorizing additional expenditures for professional services in the amount of \$6,000 in connection with work as requested by the Army Corps of Engineers and for the final report for the Bureau of Water Works, authorizing the drawing and delivery of warrants, and declaring an emergency.

The City of Portland ordains:

Section 1. The Council finds:

- That commencing in 1979, the City undertook a Finite Element Analysis of Dam No. 1 and the firm of International Engineering Company, Inc. was selected after review of proposals by Consultant Selection Committee established in accordance with Chapter 5.68 of the City Code.
- 2. That the Army Corps of Engineers requested additional work in connection with the Finite Element Analysis.
- 3. That it is necessary to amend Contract No. 17772 with International Engineering Company, Inc. to provide for the additional work for the lump sum of \$6,000, in accordance with the proposal submitted.
- 4. That is is necessary to expend \$5,300 for the final report (Phase IV in the original ordinance).

NOW, THEREFORE, the Council directs:

- a. The Mayor and Auditor are authorized to execute on behalf of the City an amendment to Contract No. 17772 with International Engineering Company, Inc. for the above-stated engineering services at a cost of \$6,000, said amendment to be substantially in accordance with Exhibit "A" attached to the original only of this Ordinance, and by this reference made a part hereof.
- b. The Mayor and Auditor are authorized to draw and deliver warrants upon receipt of invoices for services performed, said warrants not to exceed \$6,000, to be charged to the Bureau of Water Works, BUC #18600374, Object Code 210 (Professional Services), Project #1161, said warrants to be delivered to International Engineering Company, Inc., 220 Montgomery Street, San Francisco, CA 94104.

ORDINANCE No.

Section 2. The Council declares that an emergency exists in order that there be no unnecessary delay in securing engineering services for the requested additional work in analyzing Dam No. 1; therefore, this Ordinance shall be in force and effect from and after its passage by the Council.
