ORDINANCE No. 151614

An ordinance authorizing the Purchasing Agent to call for bids to furnish five (5) Hi Cube type delivery vans for the Bureau of Fleet Management; authorizing a contract with the most favorable bidder; authorizing the drawing and delivery of warrants, and declaring an emergency.

The City of Portland ordains:

Section 1. The Council finds:

- 1. Five delivery vans are required by the Bureau of Fleet Management at an estimated cost of \$57,500 to be assigned to the Bureau of Maintenance.
- 2. Ordinance 151205 authorized the transfer of \$46,000 from the General Fund to the Fleet Operating Fund for purchase of 4 of the vans identified above. The fifth is a replacement vehicle and will be paid for from Fleet's replacement account.

NOW, THEREFORE, the Council directs:

- a. The Purchasing Agent shall advertise for bids using specifications filed in his office for the vans described above, and in the event that no satisfactory bids are received, shall re-advertise using the same basic specifications until satisfactory bids are received.
- b. Contracts are authorized with the most favorable bidders as designated by the Council.
- c. The Mayor and City Auditor are hereby authorized to draw and deliver warrants chargeable to the 1980-81 Budget, Fleet Operating Fund, Bureau of Fleet Management, BUC 56200037, Expenditure Code 643 Equipment, Motor Vehicles, when demand is presented and approved by the proper authorities.

Section 2. The City Council declares that an emergency exists because a delay in proceeding with this purchase may result in additional expenses, and will unnecessarily deprive the intended Bureau the use of the new equipment; therefore, this Ordinance shall be in force and effect from and after its passage by the Council.
