

ORDINANCE No. 151619

An Ordinance repealing Ordinance No. 149768, which granted the Republican Co. a revocable permit to construct, use, and maintain a concrete tunnel for transportation of materials under and across S.W. 17th Avenue between S.W. Yamhill and S.W. Taylor Streets, and declaring an emergency.

The City of Portland ordains:

Section 1. The Council finds:

1. The Austin Co. had on behalf of the Republican Co. requested permission to construct, use, and maintain a concrete tunnel in the street area.
2. That the plans for construction of a new building were abandoned and the permit to construct a tunnel is no longer needed.

NOW, THEREFORE, the Council directs:


- a. Ordinance No. 149768 entitled "An Ordinance granting a revocable permit to the Republican Co. to construct, use, and maintain a concrete tunnel for transportation of materials under and across S.W. 17th Avenue between S.W. Yamhill and S.W. Taylor Streets, and declaring an emergency." is hereby repealed.

Section 2. The Council declares that an emergency exists in that there be no delay in clearing the records of unnecessary ordinances; therefore, this Ordinance shall be in force and effect from and after its passage by the Council.
