An Ordinance repealing Ordinance No. 143764, which granted to Mitchell Associates, Planning, a revocable permit to display flags over and across the street area of S.W. 2nd Avenue between S.W. Ankeny and S.W. Ash Streets, and declaring an emergency.

The City of Portland ordains:

Section 1. The Council finds:
