

ORDINANCE No. 151645

An Ordinance authorizing transfer of funds within the Water Fund to establish appropriation for the Small Hydro Development Program, creating one position of Engineer IV to oversee this project, and declaring an emergency.

The City of Portland ordains:

Section 1. The Council finds:

1. Generation of electric power using excess water from the Bull Run River may be feasible.
2. It is necessary to establish appropriation for the Small Hydro Development Program in order to proceed with a feasibility study and related expenses.
3. One position of Engineer IV is required by the Water Bureau in order to provide adequate supervision of the Small Hydro Program.
4. It is necessary to transfer \$170,000 within the Water Fund to establish this program's appropriation.
5. These changes have been recommended by the Administrator of the Water Bureau and approved by the Commissioner-in-charge and the Bureau of Personnel Services.

NOW, THEREFORE, the Council directs:

- a. A transfer of \$170,000 is authorized within the Water Fund from Contingency BUC 17500155, obj. code 710 to establish a Small Hydro Development Program appropriation as follows: BUC 18000369, Prj. Code 2409, Obj. Code 110, Personal Services \$1,900; Obj. Code 170, Benefits \$100; Obj. Code 210, Professional Services \$160,000; Obj. Code 590, Internal Services \$8,000.
- b. One position of Engineer IV (class 3166) is created in the Bureau of Water Works with salary rates in accordance with the current compensation plan.

Section 2. The Council declares that an emergency exists so there will be no unnecessary delay in proceeding with this project; therefore, this ordinance shall be in force and effect from and after its passage by the Council.
