

ORDINANCE No. 151676

An Ordinance authorizing a contract with Heard Construction Company to demolish and clear certain properties in the N. Going Street Noise Mitigation Project area for the Bureau of Street & Structural Engineering in the amount of \$17,750, authorizing the drawing and delivery of warrants, and declaring an emergency.

The City of Portland ordains:

Section 1. The Council finds:

1. Heard Construction Company was the lowest responsible bidder for demolition and site clearance on the N. Going Street Noise Mitigation Project for the Bureau of Street & Structural Engineering.
2. Award of a contract to said bidder for completing said project has been recommended and approved by the Commissioner-in-Charge.

NOW, THEREFORE, the Council directs:


- a. The Auditor and the Commissioner of Public Works hereby are authorized to execute a contract with the responsible bidder for the project described in Section 1 hereof in accordance with specifications filed with the Purchasing Agent.
- b. The Mayor and the Auditor hereby are authorized to draw and deliver warrants chargeable to the 1980-81 budget, General Fund, Bureau of Street & Structural Engineering, BUC #15970073, Object Code .630, when demand is presented, approved by the proper authorities.

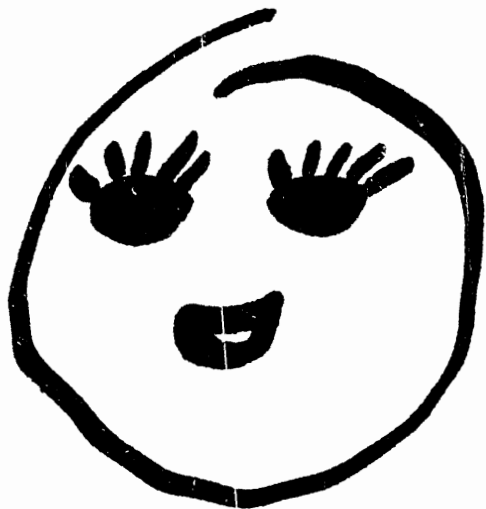

The Council declares that an emergency exists because a delay in proceeding with the purchase may result in additional expense, and will unnecessarily deprive the City of the benefits of completion of the contract at an early date; therefore, this ordinance shall be in force and effect from and after its passage by the Council.
