

**ORDINANCE No. 151681**

An Ordinance creating one Commissioner's Assistant I position and abolishing one Administrative Secretary position in the Office of the Commissioner of Public Utilities effective July 1, 1981, and declaring an emergency.

The City of Portland ordains:

Section 1. The Council finds:

1. One Commissioner's Assistant I position is required by the Office of the Commissioner of Public Utilities.
2. The new position will more clearly reflect the objectives of the Office of the Commissioner of Public Utilities.
3. One Administrative Secretary position can be abolished to provide the appropriation for the position being created.
4. The change has been approved by the Bureau of Personnel Services.

NOW, THEREFORE, the Council directs:

- a. The following position is created within the Office of the Commissioner of Public Utilities; with salary rates in accordance with the current compensation plan, and effective July 1, 1981:

- b. The following position in the Office of the Commissioner of Public Utilities is abolished:



The Council declares that an emergency exists because the position to be created is immediately required in order for the staffing requirements to be completed and the position to be abolished should not be continued unnecessarily; therefore, this ordinance shall be in force and effect after its passage by the Council.


