## ORDINANCE No. 151681

An Ordinance creating one Commissioner's Assistant I position and abolishing one Administrative Secretary position in the Office of the Commissioner of Public Utilities effective July 1, 1981, and declaring an emergency.

The City of Portland ordains:

Section 1. The Council finds:

- 1. One Commissioner's Assistant I position is required by the Office of the Commissioner of Public Utilities.
- 2. The new position will more clearly reflect the objectives of the Office of the Commissioner of Public Utilities.
- 3. One Administrative Secretary position can be abolished to provide the appropriation for the position being created.
