

ORDINANCE NO. 151701

An Ordinance amending Ordinance No. 151515 to correct the amount appropriated to the Federal Grants and General Funds by an additional \$1,800, and declaring an emergency.

The City of Portland ordains:

Section 1. The Council finds:

1. A grant award from the United States Environmental Protection Agency in the amount of \$64,000 was accepted by the Council on February 12, 1981 (Ordinance No. 151101).
2. Ordinance No. 151515, passed by the Council on May 6, 1981, incorrectly increased appropriations in the Federal Grants and General Funds by \$62,200.
3. The additional \$1,800 should be appropriated at this time.

NOW, THEREFORE, the Council directs:

- a. That Ordinance No. 151515 is amended to provide additional appropriation as follows:


ORDINANCE No.
