## ORDINANCE NO. 151701

An Ordinance amending Ordinance No. 151515 to correct the amount appropriated to the Federal Grants and General Funds by an additional \$1,800, and declaring an emergency.

The City of Portland ordains:

#### Section 1. The Council finds:

- 1. A grant award from the United States Environmental Protection Agency in the amount of \$64,000 was accepted by the Council on February 12, 1981 (Ordinance No. 151101).
- 2. Ordinance No. 151515, passed by the Council on May 6, 1981, incorrectly increased appropriations in the Federal Grants and General Funds by \$62,200.
- 3. The additional \$1,800 should be appropriated at this time.
