Legislation title: *Accept a grant in the amount of \$400,000 and appropriate \$220,797 for FY 2021-22 from the U.S. Department of Justice, Office of Justice Programs, Bureau of Justice Assistance Fiscal Year 2021 Intellectual Property Enforcement Program Competitive Grant to address intellectual property criminal enforcement in the Portland-Metropolitan region (Ordinance)

Purpose of proposed legislation and background information:

The FY 2021 Intellectual Property Enforcement Program (IPEP) grant being accepted and appropriated by this ordinance provides funding to the Police Bureau and other area agencies to support the continued work of the Intellectual Property Crimes Enforcement Task Force established under the FY 2015 IPEP grant award. The goal of the task force is to investigate and enforce IP crime to effectively protect the public's health, safety, and economic welfare by interrupting the flow of counterfeit products into the market. The bureau has been supported in these efforts since its first IPEP grant award in FY 2011.

By working as a unified group, agencies are better able to educate the public on health and safety issues, engage with the community and develop relationships to enhance communication, and complete complex investigations more efficiently and effectively. The IPCE TF was recognized by the National Intellectual Property Rights Coordination Center as model Task Force conducting proactive investigations of IP crimes, in coordination and collaboration with local, state and federal law enforcement agency partners.

Specific goals of the FY 2021 award focus on:

- Investigation and prosecution of intellectual property crimes with an emphasis on public health and safety, theft of trade secrets and economic espionage, and large scale commercial counterfeiting and piracy;
- The development and implementation of public education and outreach through a dedicated website;
- The development of a training program for all law enforcement agencies to teach investigative techniques on IP crime.

Financial and budgetary impacts:

This action will increase the Police Bureau's Grant Fund appropriation by \$220,797 for FY 2021-22. There is no match required by this grant.

Community impacts and community involvement:

The task force is developing a plan for the creation of a website designed to further the outreach and education of the community regarding intellectual property crimes. Information will include items such as what trademark counterfeiting is, how to spot it, and how to make a report and/or leave a tip.
