Moriah McSharry McGrath is on the faculty of the School of Urban Studies and Planning at Portland State University, where the bulk of her work involves teaching and mentoring students interested in housing issues. Her work relies heavily on the interplay of racism, macroeconomic policy, and real estate practices that have created today's housing landscape. Before becoming an urban studies professor, Moriah worked in the public health field, prioritizing housing as a determinant of health. While in the public health field, Moriah worked on the Rental Housing Inspections Health Impact Assessment, where she collaborated with local rental housing associations, social service providers, city bureau staff, and housing advocates to generate policy solutions for the disproportionate burden of housing code violations on communities of color in Portland.

Bio

Pippa Arend is an artist and the founder and current Development Director of p:ear, a nonprofit working with homeless youth. Pippa loves to both work with homeless young people as well as help raise funds and awareness for the cause. p:ear builds positive relationships with homeless and transitional youth (15-24 years old) through education, art, and recreation to affirm personal worth and create more meaningful and healthier lives. Pippa believes that the programs at p:ear empower each youth to establish a more positive self-identity that encompasses a renewed sense of self-worth and a capacity for growth, change and emotional challenge. Pippa is the owner of 12 units of rental housing, a lifelong Portlander, and a lifelong renter.
