ORDINANCE NO.

An Ordinance transferring \$1,682 from the General Fund to the Housing and Community Development Fund to pay for accrued vacation time; and declaring an emergency.

The City of Portland ordains:

Section 1. The City Council finds:

- 1. The City's Economic Planning Manager has been an employee of the Housing and Community Development Economic Planning Section Appropriation Unit 538 since January 19, 1981.
- 2. As of July 1, 1981, the Economic Planning Manager will be leaving City employment and will be entitled to receive all accrued vacation time pay.
- 3. Prior to employment with Appropriation Unit 538, the Economic Planning Manager was employed in a number of other City General Fund bureaus during which time there was accrued \$1,682 in vacation time.
- 4. The City Code requires that all accrued vacation time be paid from the Appropriation Unit where the employee is currently employed.
- 5. Appropriation Unit 538 has insufficient General Fund appropriation to pay for the Economic Planning Manager's accrued vacation time.
- 6. It is therefore necessary to transfer \$1,682 from the General Fund Contingency to Appropriation Unit 538 to cover these costs.

NOW, THEREFORE, the Council directs:

a. Appropriation is hereby transferred as follows:
