

ORDINANCE No. 151884

An ordinance establishing official titles, class numbers, and salary schedules for the positions of Auditorium Comptroller, and Auditorium Public Relations and Development Director, and declaring an emergency.

The City of Portland ordains:

Section 1. The Council finds:

1. The FY 1981-82 adopted budget for the Civic Auditorium included the appropriation for the positions of Auditorium Comptroller, and Auditorium Public Relations and Development Director.
2. Since these are newly-established positions, it is necessary to establish official titles, class numbers, and salary schedules for the positions.
3. The Employee Relations Officer has conducted a review of the salary rates for the new positions.
4. On the basis of that review, the Bureau of Personnel has recommended a salary schedule for these classifications.

NOW, THEREFORE, the Council directs:

Job Class Numbers, Titles, and Hourly Rates in the Compensation Plan shall be as follows:






