#### ORDINANCE No. 151895

An Ordinance authorizing the Purchasing Agent to call for bids for Custodial services at City Hall for the Bureau of Facilities Management, authorizing a contract, authorizing the drawing and delivery of warrants, and declaring an emergency.

The City of Portland ordains:

Section 1. The Council finds:

- 1. Contract No. 15194 with Coast Janitorial Services, Inc. for custodial services at City Hall has expired.
- 2. It is necessary to call for bids to continue this service.

NOW, THEREFORE, the Council directs:

- a. The Purchasing Agent shall advertise for bids using specifications filed in his office on June 17, 1981, and, in the event no satisfactory bid is received, shall readvertise on the same basic specifications until a satisfactory bid is received.
- b. The Commissioner of Public Utilities and the Auditor are authorized to execute a contract with the responsible bidder which provides the most advantageous bid to the City, in accordance with the specifications filed with the Purchasing Agent on June 17, 1981.
- c. The Mayor and Auditor are hereby authorized to draw and deliver warrants chargeable to the FY 1981-82 budget of the Bureau of Facilities Management (BUC 34800294, Project 4001, Object Code 210), when demand is presented, approved by the proper authorities.

Section 2. The Council declares that an emergency exists because a delay in calling for bids may cause an interruption in service; therefore, this Ordinance shall be in force and effect from and after its passage by the Council.
