## ORDINANCE NO. 151907

An Ordinance amending Section 17.24.020 of Title 17, Public Improvements, of the Code of the City of Portland to include a street use permit fee for certain uses of the street area; and declaring an emergency.

The City of Portland ordains:

### Section 1. The Council finds:

- 1. Ordinance No. 151642 established increases in street use permit fees and made housekeeping changes in the language of the Code, effective July 1, 1981.
- 2. Ordinance No. 151642 inadvertently omitted a street use permit fee for any other excavation, construction, reconstruction, repair, removal, abandonment, placement or use of the street area in the amount of \$10.00, as was previously included in Section 17.24.020 of the Code.
- 3. It is therefore appropriate to restore this street use permit fee to the Code.

### NOW, THEREFORE, the Council directs:

a. Section 17.24.020 of Title 17, Public Improvements, of the Code of the City of Portland is amended to read as follows:

Permi	t For	Unit Fee	Each Permit
(20)	Any other excavation, construction, reconstruction, repair, removal, abandonment, placement or use of the street area.		\$10.00

Penalty fee. If work in the street area is commenced without first securing the proper permit, the fee shall be double that prescribed above, unless the City Engineer determines that it was not reasonably possible to obtain the permit before commencing such work. Payment of the permit fee, however, shall in no way relieve or excuse any permittee from any other penalties imposed on such violation.
