ORDINANCE No. 151918

An Ordinance authorizing the gift of a portfolio of drawings by Louis Bunce to the Portland Art Association; and declaring an emergency.

The City of Portland ordains:

Section 1. The Council finds:

1. In December of 1975, the City, by the Exposition-Recreation Commission, accepted a mural by Louis Bunce, which is on display in the Georgia-Pacific Room of the Memorial Coliseum.
2. In connection with the gift of the mural, the donor gave a portfolio of drawings by Louis Bunce used in painting the mural.
3. In 1979, the Exposition-Recreation Commission loaned this portfolio of drawings to the Portland Art Association to be used for educational purposes as a part of a display of the artist's works.
4. The Exposition-Recreation Commission does not have an appropriate place to display this portfolio of drawings, which has value primarily for art education purposes, and which should be given to the Portland Art Association.
5. The Portland Art Association is willing to accept the gift of this portfolio of drawings.
6. By Resolution No. 321, the Exposition-Recreation Commission has requested the Council to pass an ordinance authorizing the gift.

NOW, THEREFORE, the Council directs:

- a. The Exposition-Recreation Commission is hereby authorized to give the portfolio of Louis Bunce drawings to the Portland Art Association.

Section 2. The Council declares that an emergency exists because delay in the effective date of this ordinance will delay the Portland Art Association's further use of the drawings.
