

## ORDINANCE No. 151919

An Ordinance authorizing the Purchasing Agent to call for bids for reroofing of University Park Community Center as part of a grant from the Department of the Interior, authorizing a contract, authorizing the drawing and delivery of warrants, and declaring an emergency.

The City of Portland ordains:

Section 1. The Council finds:

1. The Bureau of Parks requires reroofing of University Park Community Center as part of its Urban Parks and Recreation Recovery Grant from the Heritage Conservation and Recreation Service entitled "University Park Center Rehabilitation (UPARR IIIA)," and as a portion of the redevelopment of the center.
2. The Bureau of Parks has a budgeted amount of \$495,000 in the 1981-82 Budget.

NOW, THEREFORE, the Council directs:

- a. The Purchasing Agent shall advertise for bids using plans and specifications prepared by the firm of SRG Partnership, P.C., and filed in the Purchasing Agent's office by the Bureau of Parks. In the event no satisfactory bid is received, the Purchasing Agent shall readvertise on the same specifications until a satisfactory bid is received.
- b. A contract is authorized with the most favorable bidder as designated by the Council.
- c. The Commissioner of Public Safety and the Auditor hereby are authorized to draw and deliver warrants when demand is presented approved by the proper authorities.

Section 2. The Council declares that an emergency exists because delay would jeopardize the completion of the project; therefore, this ordinance shall be in force and effect from and after its passage by Council.
