

ORDINANCE No. 151925

An Ordinance extending the personal service contract of Paul Norr for services as hearings officer for a period of one year commencing July 1, 1981, and declaring an emergency.

Section 1. The Council finds:

- (1) The City has heretofore entered into a personal service contract being City Contract No. 17652 with Paul Norr, attorney at law, to provide services to the City as a hearings officer.
- (2) That the current Agreement with Mr. Norr expired June 30, 1981, and should be renewed for a period of one year commencing July 1, 1981, through June 30, 1982.
- (3) That funds for the service of Mr. Norr have been budgeted and are available in the budget of the Office of the City Attorney.

NOW, THEREFORE, the Council directs:

- (a) That the personal service contract being City Contract No. 17652 dated January 10, 1979, as amended by Ordinances Nos. 150301 and 150923 is hereby extended upon the same terms and conditions for a period of one year commencing July 1, 1981, and extending through June 30, 1982.

Section 2. This Ordinance shall be an effective extension of the above-referenced personal service contract between the City and Paul Norr upon acceptance of the terms of this Ordinance in writing and filing of such acceptance with the City Auditor.

Section 3. The Council declares that an emergency exists in order that there be no delay in extending the personal service contract of Mr. Norr for services as a hearings officer; therefore, this Ordinance shall be in force and effect from and after its passage by the Council.
