ORDINANCE NO.

151527

An Ordinance granting a Revocable Permit to C.T. and Pat Ramos, deedholders, and Gerald Kingen, Salty Pickerel's and Angus McHereford's, deedholder, to place a sign for Salty's Restaurant on the northeast corner of the site, in zone R2; located at S.E. 9th Avenue and S.E. Tacoma Street, Lots 1 and 2, Block 29, Sellwood, under certain conditions, and declaring an emergency.

The City of Portland ordains:

Section 1. The Council finds:

- 1. C.T. and Pat Ramos, deedholders, and Gerald Kingen, Salty Pickerel's and Angus McHereford's, deedholder, have filed application for a Revocable Permit to place a sign for Salty's Restaurant on the northeast corner of the site, in zone R2; located at S.E. 9th Avenue and S.E. Tacoma Street.
- 2. The legal description of said property is Lots 1 and 2, Block 29, Sellwood.
- 3. Applicants have paid the proper fee for the filing of such an application.
- 4. A duly authorized and conducted public hearing has been held by the City's Hearings Officer on June 15, 1981 (Planning Commission File No. 7071R), and the Hearings Officer recommends that a Revocable Permit to place a sign for Salty's Restaurant be allowed, under certain conditions.
- 5. The City Auditor has complied with the notice requirements of the ordinance for the hearing before the Hearings Officer.
- 6. A sign indicating the location of Salty's Restaurant would appear to guide traffic in a more direct manner to the restaurant. The sign could be easily removed and it would not affect the Zoning Code enforcement of surrounding property or on this property.

NOW, THEREFORE, the Council directs:

- a. That the facts, findings, conclusions, and recommendation of the Hearings Officer in P.C. File No. 7071R are adopted by City Council.
- b. That a Revocable Permit be granted to place a sign for Salty's Restaurant on the northeast corner of the site, in zone R2; located at S.E. 9th Avenue and S.E. Tacoma, Lot 1 and 2, Block 29, Sellwood.
- c. This Revocable Permit is granted under the following conditions:
 - 1) The sign shall be located on the northeast corner of the site, five feet from the S.E. Tacoma property line and four feet from the S.E. 9th property line.

- 2) The deciduous tree on the site shall remain and shall only be removed if the tree becomes diseased and that disease is certified by the City Forester.
- 3) Permits from the Bureau of Buildings shall be obtained prior to locating the sign on this site.
- 4) The sign shall portray only the words "Salty's" and a directional arrow.
- 5) The illumination shall be limited to light cast only on the faces of the sign.
- 6) The lights and the sign shall be as vandal proof as possible.
- 7) The applicants shall meet with the Bureau of Planning and Traffic Engineers, together with a representative of the neighborhood, in order to address the problems of traffic on 9th Avenue. Among those topics for investigation should be an additional sign at S.E. Tacoma Street and 17th Avenue to channel westbound traffic, stop signs on 9th Avenue, other warning signs along 9th Avenue.
- 8) The Revocable Permit hereby granted is personal to the permittee and may not be transferred, assigned or otherwise disposed of by said permittee.
- 9) The Revocable Permit hereby granted shall be revocable at the pleasure of the City Council and no expenditures of money hereunder or lapse of time or any act or thing shall operate as an estoppel against the City of Portland, or be held to give the permittees any vested or other right.
- 10) Permittee shall comply with the provisions of the Code of the City of Portland, and all other applicable ordinances, provisions and regulations of the City, whether presently existing or hereafter enacted.
- d. Neither this ordinance nor any permit issued hereunder shall be effective until accepted, filed and recorded in accordance with law.
- Section 2. The Council declares an emergency exists because there should be no delay in the beneficial use of the above-described property; therefore, this ordinance shall be in force and effect from and after its passage by the Council.
