ORDINANCE No. 151935

An Ordinance amending Ordinance No. 151756, being an ordinance assessing upon certain property the cost of repairing and constructing sidewalks, curbs and driveways in front thereof, for the one-month billing period ended March 31, 1981, by cancelling the assessment for Firland, Block 17, $S \frac{1}{2}$ of Lot 15, and reducing the total assessment by \$96.36, and declaring an emergency.

The City of Portland ordains:

Section 1. The Council finds:

- 1. Ordinance No. 151756 assessed Firland, Block 17, S½ of Lot 15, \$96.36 for the repair and construction of sidewalks, curbs and driveways in front thereof, for the one-month billing period ended March 31, 1981, and entered in City Lien Docket Book 125, Page 156.
- 2. This lien was paid as an invoice and should not be included in the assessment.

NOW, THEREFORE, the Council directs:

- a. Ordinance No. 151756 is amended by cancelling the assessment against Firland, Block 17, S ½ of Lot 15, by \$96.36 and reducing the total assessment of \$21,431.26 to \$21,334.90.
- Section 2. The Council declares that an emergency exists because of the necessity of keeping the City's financial records accurate; therefore, this ordinance shall be in force and effect from and after its bassage by the Council.
