ORDINANCE No. 151937

An Ordinance authorizing the Purchasing Agent to call for bids for the construction of the Veterans Hospital Supply Main for the Bureau of Water Works, authorizing a contract, the drawing and delivery of warrants, transferring \$134,000.00 within the Water Fund from contingencies, and declaring an emergency.

The City of Portland ordains:

Section 1. The Council finds:

- 1. A new supply main is required to provide adequate water service for the proposed U.S. Veterans Hospital.
- 2. The transfer of \$134,000.00 is necessary from contingency to provide for construction of the main.

NOW, THEREFORE, the Council directs:

- a. The Purchasing Agent shall advertise for bids using specifications filed in his office on July 2, 1981, and in the event that no satisfactory bid is received, shall readvertise on the same basic specifications until a satisfactory bid is received.
- b. A contract is authorized with the most favorable bidder as designated by Council.
- c. \$134,000.00 is transferred within the Water Fund from contingencies to the Main Program, Project No. 3476, BUC No. 18600374, Object Code 630.
- d. The Mayor and Auditor are hereby authorized to draw and deliver warrants chargeable to the 1981-82 Budget, RU 186, Water Fund, Veterans Hospital Supply Main, Project No. 3476 (BUC No. 18600374) when demand is presented, and approved by the proper authorities.
- Section 2. The Council declares that an emergency exists because a delay in proceeding with the project may result in additional expense and will unnecessarily delay the provision of adequate water service to the affected areas; therefore, this Ordinance shall be in force and effect from and after its passage by the Council.
