

ORDINANCE NO. 151943

An Ordinance authorizing the Purchasing Agent to call for bids for Custodial services at East Precinct for the Bureau of Facilities Management, authorizing a contract, authorizing the drawing and delivery of warrants, and declaring an emergency.

The City of Portland ordains:

Section 1. The Council finds:

1. On November 1, 1980 the City entered into contract #19184 with Park Building Maintenance, Inc. for custodial service at five locations.
2. The level of custodial service at East Precinct location were found unsatisfactory and contract was terminated by Ordinance #151395, dated April 15, 1981, with Park Building Maintenance.
3. It is necessary to call for bids to continue this service.

NOW, THEREFORE, the Council directs:

- a. The Purchasing Agent shall advertise for bids using specifications filed in his office July 8, 1981, and, in the event no satisfactory bid is received, shall readvertise on the same basic specifications until a satisfactory bid is received.
- b. The Commissioner of Public Utilities and the Auditor are authorized to execute a contract with the responsible bidder which provides the most advantageous bid to the City, in accordance with the specifications filed with the Purchasing Agent on July 8, 1981.
- c. The Mayor and Auditor are hereby authorized to draw and deliver warrants chargeable to the FY 1981-82 budget of the Bureau of Facilities Management (BUC 34900294, Project 4021 Object Code 210), when demand is presented, approved by the proper authorities.

ORDINANCE No.

Section 2. The Council declares that an emergency exists because a delay in calling for bids may cause an interruption in services; therefore, this Ordinance shall be in force and effect from and after its passage by the Council.
