

ORDINANCE NO. 1519-16

An Ordinance accepting two street deeds for the SE Lents Street Improvement Project District II, granted by Rolland M. Hanson and Colleen L. Hanson, and Reed Holman, authorizing total payment of \$575.00, and declaring an emergency.

The City of Portland ordains:

Section 1. The Council Finds:

- 1. Right of way is required for construction of the SE Lents Street Improvement Project District II.
- 2. Rolland M. Hanson and Colleen L. Hanson, and Reed Holman have conveyed the required right of way to the City for the total sum of \$575.00.

NOW, THEREFORE, the Council directs:

a. That the following described tract is hereby accepted for street purposes:

R/W #3728-4

The north 5.0 feet of the east one-half of Lot B, Block 1, Gordon Place, in the City of Portland, County of Multnomah and State of Oregon. (Granted by Reed L. Holman, Rolland M. Hanson and Colleen L. Hanson).

b. The Mayor and Auditor to draw and deliver a warrant in payment for the above described tract in the amount and in favor of the following:

said warrant to be charged to BUC 15923300 (Job #6006) and will be 100% reimbursed by the Housing and Community Development Fund.

c. The Auditor shall record in the appropriate deed records, documents of title as necessary for purchase of this right of way.

## ORDINANCE No.

Section 2. The Council declares that an emergency exists because a delay in the acceptance of the street deeds might result in delays in construction; therefore, this Ordinance shall be in force and effect from and after its passage by the Council.
