ORDINANCE NO. 151953

An Ordinance granting a revocable permit to McCracken Motor Freight Inc. to construct and maintain two (2) oversize driveways by enlarging two (2) existing driveways on the south side of N.W. Front Avenue, at a fee of \$187.00, and declaring an emergency.

The City of Portland ordains:

Section 1. The Council finds:

- 1. Section 17.28.110 of the City Code requires Council approval for construction of a driveway larger than the limits set forth therein.
- 2. McCracken Motor Freight Inc., owner of the property at 3147 N.W. Front Avenue, Portland, Oregon, 97210, has requested permission to construct and maintain an oversize concrete service driveway in the street area adjacent thereto.
- 3. That the applicant has applied for a permit to build an additional loading dock, Building Permit Application No. 1922.
- 4. That the proposed oversize driveways under certain conditions would not be detrimental to the public interest.

NOW, THEREFORE, the Council directs:

- a. A revocable permit to run with the land is granted to McCracken Motor Freight Inc., permittee, to construct and maintain an oversize concrete service driveway in the street area adjacent to Tax Lot 58, Section 28, 1 north, 1 east, and located as shown on the plan marked "Exhibit A" attached to and by this reference made a part of this Ordinance, subject to the following conditions:
 - (1) This permit is for the use of the street area only, and shall not exempt the permittee from obtaining any license or permit required by the City Code or Ordinances for any act to be performed under this permit, nor shall this permit waive the provisions of any City Code, Ordinance, or the City Charter, except as herein stated.
 - (2) This permit is revocable at any time in the event the public's need requires it and no expenditure of money hereunder, lapse of time, or other act or thing shall operate as an estoppel against the City of Portland, or be held to give the permittee any vested or other right. Immediately upon the expiration of this permit, or upon its sooner revocation by the Council, the permittee shall remove said oversize driveway from the street area as directed by and to the satisfaction of the City Engineer.

- (3) The permittee shall pay the permit fee of \$187.00 required by Section 17.24.020 of the City Code.
- (4) The permittee shall reimburse the City for the cost of filing by the City Auditor of a certified copy of this Ordinance with the Records Division of Multnomah County.
- Section 2. This Ordinance will not become effective until the permittee has filed with the City Auditor a document, which has been approved by the City Attorney, accepting the terms and conditions hereof. This Ordinance shall be automatically revoked without further consideration by the Council if the acceptance together with documents and fees required are not on file with the City Auditor within sixty (60) calendar days of the passage of this Ordinance.
- Section 3. The Council declares that an emergency exists because delay in the enactment of this Ordinance will result in an unnecessary hardship of uncertainty on the part of the applicant as to the status of the requested permit; therefore, this Ordinance shall be in force and effect from and after its passage by the Council.
