

# ORDINANCE No. 151954

An Ordinance repealing Ordinance No. 144672, which granted a revocable permit to Paul Gold, to construct and maintain a marquee in the sidewalk area of S.W. 2nd Avenue near S.W. Taylor Street, and declaring an emergency.

The City of Portland ordains:

Section 1. The Council finds:

1. Paul Gold, 1017 S.W. Washington Street, requested permission to construct and maintain a marquee in the sidewalk area of S.W. 2nd Avenue adjacent to Lots 1 and 2, Block 23, Portland.
2. The permittee is deceased.
3. The marquee no longer exists.

NOW, THEREFORE, the Council directs:

- a. Ordinance No. 144672 entitled "An Ordinance granting a revocable permit to Paul Gold to construct and maintain a marquee, with variations from the City Code, in S.W. 2nd Avenue near S.W. Taylor Street, and declaring an emergency." is hereby repealed.

Section 2. The Council declares that an emergency exists in that there be no delay in clearing the records of unnecessary ordinances; therefore, this Ordinance shall be in force and effect from and after its passage by the Council.
