ORDINANCE NO. 1519632

An Ordinance authorizing the Purchasing Agent to call for bids for Contract Services for hauling and utilization of wastewater sludge, for the Bureau of Wastewater Treatment, authorizing a contract with the bidder whose bid is most advantageous to the City, authorizing drawing and delivery of warrants, and declaring an emergency.

The City of Portland ordains:

Section 1. The Council finds:

- 1. That the Office of Public Works Administrator, for the Bureau of Wastewater Treatment, by and through the Bureau of Sanitary Engineering proposes to contact for disposal of wastewater sludge in accordance with the specifications filed with the Purchasing Agent.
- 2. That Resolution No. 32906 adopted by the Council on April 22, 1981, directed the Public Works Administrator to investigate marketing of partially dewatered sludge.

NOW THEREFORE, the Council directs:

- a. The Purchasing Agent shall advertise for bids using the specifications filed in his office.
- b. The Commissioner of Public Works and the Auditor hereby are authorized to execute a contract with the bidder whose bid is most advantageous to the City for the project described in Section 1 hereof in accordance with the specifications filed with the Purchasing Agent.
- c. The Mayor and the Auditor hereby are authorized to draw and deliver warrants chargeable to the 1981-82 Budget; Bureau of Wastewater Treatment, Operations Division, RU 151, Operate Vacuum Filters, Object Code 220, Utilities, Refuse Disposal, when demand is presented and approved by proper authority.
- Section 2. The Council declares that an emergency exists because this contract would reduce the amount of wastewater sludge being disposed

of at the St. Johns Landfill; therefore, this ordinance shall be in force and effect from and after its passage by the Council.
