

# ORDINANCE No. 151988

An Ordinance amending the City Compensation Plan by establishing a position of Solid Waste Coordinator and a rate of pay effective on July, 1981, and declaring an emergency.

The City of Portland ordains:

Section 1. The Council finds:

1. That the FY 81-82 approved budget for the Bureau of Refuse Disposal authorized a full time position of Solid Waste Coordinator and appropriated funds for its salary.
2. That the Bureau of Personnel Services has reviewed the position and its duties and recommended on June 12, 1981 a commensurate rate of pay to be established.
3. That the rate of pay should be effective on July 1, 1981 because the Department of Public Works has engaged the services of an individual to fill the vacancy on July 1, 1981.

NOW, THEREFORE, the Council directs:

- a. The City Compensation Plan be amended to establish a new Civil Service class of Solid Waste Coordinator, Class No. 1831, and a rate of pay for FY 81-82 based on the following FY 80-81 salary rate schedule:

<u>Entry</u>	<u>1 Year</u>	<u>2 Year</u>
\$13.13	\$13.52	\$13.95

- b. The Compensation Plan amendment in paragraph a., above, be in effect on July 1, 1981.

Section 2. The Council declares that an emergency exists because a delay in establishing a Solid Waste Coordinator position and commensurate rate of pay will inhibit the City's ability to exercise its solid waste collection system regulation authority and its ability to effectively participate in regional solid waste decision-making; therefore, this ordinance shall be in force and effect from and after its passage by the Council.
