

## ORDINANCE NO. 151994

An Ordinance creating one position of Information Specialist, one position of Community Relations Coordinator, one position of Assistant Management Analyst and abolishing one position of Information/Community Relations Technician in the Bureau of Parks, effective July 1, 1981, transferring \$47,391 within the General Fund from General Operating Contingencies to the Bureau of Parks,

The City of Portland ordains:

## Section 1. The Council finds:

1. One position of Information Specialist, one position of Community Relations Coordinator, and one position of Assistant Management Analyst are required by the Bureau of Parks, Office of the Superintendent.
2. One position of Information/Community Relations Technician can be abolished to provide partial appropriation for the positions being created.
3. The necessary additional appropriation should be provided by transfer within the General Fund from General Operating Contingency to the Bureau of Parks 1981-82 budget.

NOW, THEREFORE, the Council directs:

- a. The following positions are created in the Bureau of Parks with salary rates in accordance with the current Compensation Plan:
