Dear Mayor Wheeler,

On behalf of the nearly 15,000 janitors, security officers, and healthcare workers of the Service Employees International Union, Local 49, I am writing to express our frustration and disappointment with the City's lease renewal for the Fire & Police Disability and Retirement Board in Harrison Square, a building that replaced its long-time union janitors with a low road contractor in early 2020.

Every City expenditure is an opportunity to ensure taxpayer dollars are doing as much as possible for our communities. When the City leases space in buildings cleaned and secured by union janitors and security officers, the City is ensuring that *all* jobs created by public dollars are good jobs. Responsible union contractors create jobs that include fair wages and benefits, provide workers with a voice on the job, and prioritize health and safety measures— and they add clear value to the City's investment by ensuring high quality service and stability resulting from lower worker turnover.

In contrast, leasing space in buildings cleaned and secured by low-cost contractors that offer lower wages and benefits can put taxpayers' investment at risk by exposing City offices to inconsistent cleaning quality and diminished safety and security due to higher rates of turnover.

This lease renewal is particularly upsetting as it comes at a time when low wage workers – and particularly Black and indigenous workers of color and frontline essential workers like janitors – have borne the brunt of the pandemic's challenges and inequities. Moving forward, we ask that the City meet with us to continue this discussion and to ensure that the City employ higher scrutiny and exhibit a greater commitment to responsible City leasing.
