## ORDINANCE NO. 152875

An Ordinance amending Contract No. 19651 between the City of Portland and the Portland Development Commission, increasing the amount of the contract by \$133,681 per the Supplemental Budget and the Second Quarter Budget Review Ordinance; and declaring an emergency.

The City of Portland ordains:

#### Section 1. The Council finds that:

- 1. By Resolution 33059, passed January 6, 1982, the Council directed the Office of Fiscal Administration to submit a Supplemental Budget to the Multnomah County Tax Supervising and Conservation Commission.
- 2. The Housing and Community Development fund was included in the Supplemental Budget.
- 3. The HCD Supplemental Budget included appropriation adjustment for the Portland Development Commission as follows: carry-over, funding adjustments and additional funding for projects approved in FY 81-82 for a total contract increase of \$110,823.
- 4. The Supplemental Budget was submitted to the Tax Supervising and Conservation Commission and a public hearing was held on Thursday, February 11, 1982.
- 5. Council approved funding for Rivereast Progress, Inc. in the Second Quarter Budget Review in the amount of \$22,858.
- 6. Funding for Rivereast Progress, Inc. will be included in the PDC contract in the amount of \$22,858.
- 7. Contract No. 19651 between the City of Portland and the Portland Development Commission needs to be amended by increasing the total amount by \$133,681 to include the Supplemental Budget and Second Quarter Review Ordinances.

### NOW, THEREFORE, the Council directs:

- a. That Contract No. 19651 between the City of Portland and the Portland Development Commission is hereby amended by increasing the total amount by \$133,681
- b. The Mayor and Auditor are hereby authorized to draw and deliver warrants for said contract from the Housing and Community Development fund.

## ORDINANCE No.

- Section 2. This Ordinance shall not become effective until the contractee (Portland Development Commission) has filed with the City Auditor a document accepting the terms and conditions hereof which has been approved by the City Attorney.
- Section 3. So that there will be no delay in implementing the provisions in this Ordinance, the Council declares that an emergency exists and this Ordinance shall be in force and effect from and after its passage by Council.
