ORDINANCE NO. 152894

An Ordinance authorizing the Purchasing Agent to advertise and receive proposals to finance the purchase of Telephone Exchange Equipment for The Portland Building and Police Facility in the Justice Center, authorizing a contract, authorizing the drawing and delivery of warrants, and declaring an emergency.

The City of Portland ordains:

Section 1. The Council finds:

- 1. On December 3, 1981, the City entered into Contract No. 19813 with American Business Communications, Inc. to acquire and install a Digital Electronic Automatic Branch Telephone System (Telephone Exchange) in The Portland Building and Police Facility in the Justice Center.
- 2. The report to Council recommended that the City seek financing for the Telephone Exchange equipment other than that offered by American Business Communications.
- 3. The City has hired Government Finance Associates, Inc. to assist in preparation of the request for proposal for financing the Telephone Exchange equipment as part of its financial consulting services to the City.
- 4. The form of request for proposal on file in the office of the Purchasing Agent is recommended by the financial consultant.

NOW, THEREFORE, The Council directs:

- a. The Purchasing Agent shall advertise for proposals to finance the lease/purchase of Telephone Exchange equipment for The Portland Building and Police Facility in the Justice Center using specifications on file in his office on the effective date of this Ordinance, and in the event that no satisfactory bids are received, shall readvertise using the same basic specifications until satisfactory bids are received.
- b. Contracts are authorized with the most favorable bidder as designated by the Council.
- c. The Mayor and Auditor are hereby authorized to draw and deliver warrants chargeable to the 1982-83 Budget, Office of General Services, when demand is presented and approved by proper authorities.

ORDINANCE No.

Section 2. The City Council declares that an emergency exists because a delay in proceeding with obtaining the financing of the Telephone Exchange equipment may delay the City occupancy of The Portland Building; therefore, this ordinance shall be in force and effect from and after its passage by the Council.
