APPEAL INFORMATION SHEET

Appeal item 1

Code Section R310.1

Requires R310.1 - requires egress window in each bedroom

Proposed Design Permit 07-156572 RS included conversion of basement with one bedroom and egress window. This permit was finalized. Permit records are unavailable from microfiche and archives, but there are records for revision.

This permit appears to have been finalized with the egress window in the bedroom closet. Owner is remodeling basement and would like the existing egress window for adjoining bedroom to remain.

Reason for alternative From examination of construction, closet access was through pocket door, which appears to have been built under the 2007 permit, at the time bathroom was added.

By expanding bathroom into area that was small closet, owner is making access to egress window better, by enlarging area that provides access to egress window.

APPEAL DECISION

Bedroom egress window located in bathroom: Granted provided there is no lock on bathroom door.



The Administrative Appeal Board finds with the conditions noted, that the information submitted by the appellant demonstrates that the approved modifications or alternate methods are consistent with the intent of the code; do not lessen health, safety, accessibility, life, fire safety or structural requirements; and that special conditions unique to this project make strict application of those code sections impractical.

Pursuant to City Code Chapter 24.10, you may appeal this decision to the Building Code Board of Appeal within 180 calendar days of the date this decision is published. 


