The City of Portland ordains:

Section 1. The Council finds:

- 1. On December 3, 1981, the City entered into Contract No. 19813 with American Business Communications, Inc., to acquire and install a Digital Electronic Branch Telephone System (Telephone Exchange) in The Portland Building and Police Facility in the Justice Center.
- 2. Said contract with American Business Communications provides that the City will make progress payments and that \$471,981 is due when one-half of the cabling is complete and computer switch is delivered. American Business Communications is expected to meet this requirement on March 15, 1982.
- 3. On February 24, 1982, the Council adopted Ordinance No. 152894 which authorized the Purchasing Agent to advertise and receive proposals to finance the acquisition of the Telephone Exchange, said proposals to be received on March 16, 1982.
- 4. It is necessary for the City to pay American Business Communications from current City resources pending selection of a financing agent and closing Telephone Exchange financing arrangements.

NOW, THEREFORE, The Council directs:

a. Appropriations are transferred as follows:

From General Fund Operating Contingency, Unforeseen Reimbursable Expenditures BUC 29800014 \$472,000 To Special Appropriation #400 BUC 40000551.640 \$472,000

- The Mayor and Auditor are hereby authorized to draw and ь. deliver warrants not to exceed \$472,000, chargeable to Special Appropriation #400, when demand is presented and approved by proper authorities.
- Section 2. The Council declares that an emergency exists because a delay would prevent the timely payment of contractual obligations; therefore, this ordinance shall be in force and effect from and after its passage by the Council.
