


<b>Code Section</b>	ORSC/3/#1
<b>Requires</b>	a. Stairways must be at least 30 inches wide; and b. Stairway headroom must be at least 6 feet 2 inches
<b>Proposed Design</b>	Stairs already built by construction company prior to our purchase of the house. See attached (to be emailed by 9am on Monday 4/5/19).  Each stair is 9" long and 7.75" high Width of the stairway is 28"
<b>Reason for alternative</b>	This staircase provides access to the downstairs bathroom. There is additional egress to Ivon Street from the bottom of the stairs through the laundry room.  Changing this staircase would require moving of structural elements in the walls. It would require rebuilding several areas - the kitchen, the laundry room, and the basement.  Above• the staircase is a staircase to the attic.

**Site Plan**






